**DRAWS:**

The Early Bird Draw #1 will be held at 2pm on October 12<sup>th</sup>, 2023, at the office of Stride Management Corp. 3950 -12 Street NE, Calgary Alberta. All tickets are eligible for all draws. Only tickets received at the Lottery Ticket Sales Centre before 11:59 pm October 3<sup>rd</sup>, 2023, will be eligible for this draw.

The Early Bird Draw #2 will be held at 2pm on January 9<sup>th</sup>, 2024, at the office of Stride Management Corp. 3950 -12 Street NE, Calgary Alberta. All tickets are eligible for all draws. Only tickets received at the Lottery Ticket Sales Centre before 11:59 pm December 29<sup>th</sup>, 2023, will be eligible for this draw.

The Early Bird Draw #3 will be held at 2pm on April 30<sup>th</sup>, 2024, at the office of Stride Management Corp. 3950 -12 Street NE, Calgary Alberta. All tickets are eligible for all draws. Only tickets received at the Lottery Ticket Sales Centre before 11:59 pm April 17<sup>th</sup>, 2024, will be eligible for this draw.

The Final Draw will be held at 2pm on August 28<sup>th</sup>, 2024, at the office of Stride Management Corp. 3950 -12 Street NE, Calgary Alberta. All tickets are eligible for all draws. Only tickets received at the Lottery Ticket Sales Centre before 11:59 pm August 25<sup>th</sup>, 2024, will be eligible for this draw.

All draws are open to the public. Two member delegates of the Licensee will attend and witness the draw.

Prize draws follow a strict set of procedures, with draw control oversight by Stride Management Corp. and under licensing approval of the Alberta Gaming, Liquor and Cannabis (AGLC). Age limit for ticket purchasers is 18 years old and over. Purchase must be made in the province of Alberta. The Lottery draws are conducted using an RNG (Random Number Generator) system. The winning raffle draw number shall be determined from the pool of sold raffle ticket numbers. This will include all Early Bird draws and final draw.

Only upon demonstrating extraordinary circumstances to the AGLC will the Licensee make a request for a draw date extension.

Files are continuously backed up by Stride Management Corp. In the unexpected event of a power failure, the draw will be postponed and take place immediately once power has been restored.

**ELIGIBILITY:**

Raffle guidelines prohibit the following people from purchasing tickets: The Lottery Manager, the Lottery Committee, employees of Stride Management Corp., members of the Kinsmen Club of Taber, immediate family of those listed above and anyone under the age of 18. The Licensee will advise all purchasers not to include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act.

**PRIZES:**

There are 3 Early Bird Prize Draws

- Early Bird #1 Prize \$1,500.00
- Early Bird #2 Prize \$2,500.00
- Early Bird #3 Prize \$3,500.00

All Early Bird winning tickets will be returned to the draw and are eligible for subsequent 2023-2024 draws/prizes.

There will be one final draw. Final prize is a choice between ONE of the 5 following options:

- \$50,000.00 In-Store Credit at River Runner Recreation, Taber, Alberta.
- \$50,000.00 In-Store Credit at College Ford, Taber, Alberta.
- \$50,000.00 In-Store Credit at McDonald Chevrolet, Taber, Alberta.
- \$50,000.00 In-Store Credit at Legacy Dodge, Taber, Alberta.
- \$40,000.00 Cash

All winners will be notified by representatives of the Kinsmen Club of Taber detailing what they have won and where they can claim their prize(s). The names, cities and winning ticket numbers will be published within 14 days following the draw on the lottery website at <https://taberkinsmen.ca/kar-affle/>

Prizes must be accepted as awarded, there will be no cash substitutes unless indicated.

All prizes must be claimed within three months from the final draw date. If any prize(s) remains unclaimed for more than three (3) months from the date of the draw, a request will be made to the AGLC regarding the disbursement of the unclaimed prizes. For the choice of the final prize however, when the winner has been contacted either in person, by telephone, or registered mail, the winner has two weeks from the time of notification of winning the raffle to decide upon their choice of prize and notify the KinKar Raffle Chairman. Should the winner not make a choice of prize within the two-week period they must accept the \$40,000.00 (cash option) as the final prize.

In the event a winning ticket stub lists more than one name, the licensed charity shall award the prize to only one of the individuals identified on the ticket, and the licensed charity and the AGLC are not responsible for any disputes which may arise between the different individuals.

There is a total of 4 prizes. Retail value of all the prizes is **\$57,500.00 (or \$47,500.00 if cash option is selected on final draw).**

**TICKETS:**

All sets of multiple tickets must contain the same information. All tickets will be controlled by Stride Management Corp. and are only available online, and at designated sales locations or outlets identified by the committee as required.

Tickets may be purchased with VISA, MasterCard & bank debit card. The Licensee's liability is limited to the purchase price of the ticket.

If any purchased ticket has been entered for any draw, no refund will be issued.

83,950 tickets are available and consist of; single tickets at \$20 each; sets of 5 tickets for \$50: sets of 25 tickets for \$100; and sets of 75 tickets for \$150;
